General Rules and Regulations

- No shooting unless a Range Master is present.
- 2. The Range Master has absolute control of the range and its operation while the range is open.
- No alcoholic beverages are to be consumed on the range property while the range is open for shooting.
- No one will be allowed on the range if they appear to be under the influence of alcohol or narcotics.
- No one under 18 years of age will be allowed to shoot unless accompanied by an adult.
- Eye and ear protection is mandatory on the shooting level-except during a cease-fire.
- 7. A maximum of two people per shooting bench/stall at any one time; one shooter and one spotter.
- 8. All guns shall remain unloaded if not in the process of being fired. Use of chamber flag/Open Bore Indicator is mandatory with actions open and the magazine empty or removed at all times behind the red line and to/from the firing point; and on the bench for a cease fire.
- 9. Repairs and cleaning shall be performed at the tables behind the firing line. Bore swabbing (from the action) and rifle adjustments may be performed on the firing line (except during cease fire).
- 10. Handguns may be used only on the handgun range. Rifle caliber handguns must be shot off the bench on the rifle range only at targets of sufficient height above ground level to prevent ricochet or target stand base damage.
- 11. There is to be no open carry of a handgun at the range, except by law enforcement.
- 12. Paper targets only, unless cleared through the Range Master, may be used on either range.
- 13. Failure to observe all rules and regulations or failure to obey Range Master commands shall be sufficient reason to be expelled from the range.
- 14. Cease fire -- unless you go down range for your target or shooting aid equipment you must remain behind the red line. Do not approach guns or the benches at the firing line.
- 15. There is no shooting at objects on the flat and hard surfaces of the range. There is no shooting of range markers or non-target equipment.
- 16. Clean up all brass and place into barrel for recycling. All cleaning patches and trash must be thrown away.
- 17. Wash your hands after handling ammunition and always before eating.
- Please report any unsafe activity or damaged equipment to the range master.

Range Procedures

- 1. Every shooter must sign a log book. Rifle range users must sign the range log book. Only full members may use the pistol range, and pistol shooters must sign the pistol log book.
- 2. Each shooter is responsible for his or her target stand. Remove your targets and return stands to the rack before you leave.
- 3. At the discretion of the Range Master, a cease fire will be called to allow shooters to go down range to set, check or pick up targets. For safety, anyone can call a cease fire at any time and must be observed immediately.
- 4. Range Master will say: "Cease-fire, open your actions and step behind the red line. You may now check your targets, the range is cold". [Red Light] - No one is allowed between the red line and the benches at this time.
- 5. Range Master will say: "Ready on the left, ready on the right, ready on the firing line, Commence Fire. The range is now Hot" [Green Light] - Shooters may not move forward of the benches.

I have read and understand the above rules and regulations. I agree to abide by these rules and will handle all firearms in a safe manner. I also promise to support and defend the Constitution of the United States and the State of California.
